**Notice on Finalization of Details of Issuance of
Stock Compensation-type Stock Options (Stock Acquisition Rights)**

Nippon Sheet Glass Co., Ltd. has decided the subscription requirements of Stock Acquisition Rights, in the form of stock options, to be allotted to certain Executive Officers and Corporate Officers on 12 September 2017, and the details of issuance of the Stock Acquisition Rights were finalized today as follows:
